 - a. Director's Report
 - i. Community development fundraising (Jack Roberts) Jack has raised 2.3 million dollars over the past few years. He would like to put more of his efforts toward fundraising and spend a portion of his time working at Mountain Song towards community development (see handout). Staff present voiced their desire to see Jack take on fundraising. Mike to work on offer letter.

Laura & Angela are working on the budget deficit regarding the food program. K tuition discount and a before-care program need to be considered. The Board will meet for a working session to discuss these programs and budget decisions in-depth.

Tour of Bates occurred this morning; and they want a bid in by March 31st. Board members are opposed to making a hasty decision. Ask D11 if we can extend the bid date from March 31st.

They also offered a space for a P/C class to free up space on our campus for grades' classrooms.
- v. Parent Child Program Program not sustainable due to over-estimation on enrollment. Laurie, Eva, Linda and Mike will meet to discuss how we will move forward.
